Sibling Discount: **2.5%** for the second child, **7%** for the third, and **10%** for the fourth.

Prepayment Discount: **2%** if received by **15th July 2026**.

Mid-Year Entries to School: Reduced school fees will be charged when a child enters the school during mid-year:

Second term entry point 65% of annual fees

Third term entry point 35% of annual fees

Other Fees Applicable (For Applications Submitted on/after 1 October 2026)

Application Fee	Payable when the application is submitted. This is non-refundable and goes towards the administrative costs of the application.	€ 200
Registration Fee	A one-off payment per child, (payable by the date specified on the official letter of offer) to secure the place. This is NOT a deposit against future tuition fees and is non-refundable .	€1,500
Development Fee	A one-off payment per child payable at the same time as the Registration Fee (i.e.: by the date specified on the official letter of offer). This is a contribution towards the ongoing development of the school.	Nursery to Year 11: €2,000 Year 12 to 13: €500
Cancellation Fee	If your child is unable to commence at the school, please notify the Admission Team in writing. A Cancellation Fee will be charged according to their Year group placement. If you re-apply for your child's admission in the future, their Registration Fee, which has already been paid, will be valid for two academic years (24 months) from initial payment.	Nursery to Year 11: €2,000 Year 12 to 13: €500
Tuition Fee Reservation Deposit For School Year 2027-28	A non-refundable deposit payment is due annually to reserve your child's place for the following academic year. This will be credited against the invoice billed in September. Please note that the reservation deposit is only considered payable once your current balance has been settled in full. This will be allocated against invoice billed in September.	€2,500

Tuition Fees: Fees are invoiced twice per year (September and January). For all students joining the School during the academic year, fees are calculated in term entry points (refer to Fee Schedule). No refund is available for children leaving the School mid-term.

Additional Charges: Parents pay all examination charges for externally marked examinations. In addition, tuition fees do not include daily transportation costs, uniform costs, medical examination charges, external examinations, entry fees, cost of special outings / compulsory trips for the children or any other fees or charges that are unique to individual children as well as co-curricular clubs. It is the parents' own responsibility to purchase textbooks for Year 10 through Year 13.

Applications: Payment of €200 must be paid immediately upon application. Once an official offer has been made, the Registration Fee and Development Fee will become payable. A Cancellation Fee will be charged if a child's enrolment is cancelled (refer to Other Fees table under the Fee Schedule).

Mid-Year Arrivals: New families joining during second or third terms pay reduced fees dependent on point of entry (refer to Mid-Year Entries to School paragraph above). Any families joining mid first term must pay the full amount.

Payment of Fees: Payment of fees can be made either by using the RF code provided by the Financial Administrator, cheque (in euros) payable to "St. Catherine's British School", credit cards (Visa & MasterCard), bank transfer or direct deposit to our bank account (details set out below) always making sure to advise the Financial Administrator. *Fees in cash are not accepted.*

Fees must be paid promptly and certainly within 10 working days of receipt of invoice. Late payment charges of €60 per month will be applied to outstanding balances. Any time during the school year, the school may initiate immediate legal action if the tuition fees payment are more than 30 days overdue. If, following legal action, the family wishes for the child(ren) to continue attending the school, all outstanding fees must be paid in full, together with the full first invoice for the forthcoming school year, before readmission can be granted.
